ORDINANCE NO. 816

AN ORDINANCE AMENDING TITLE 7, CHAPTER 4, SECTION 2.A OF THE CITY CODE – CITY PARK HOURS

WHEREAS, the City of Assumption, Christian County, State of Illinois, (“City”) is a duly organized and existing city created and operating under the provisions of the Illinois Municipal Code and laws of the State of Illinois; and,

WHEREAS, the Illinois Municipal Code provides that municipalities may pass and enforce all necessary police ordinances; prevent or suppress noises, disturbances, and trespasses; define and abate nuisances; regulate the use of the streets and other municipal property; and prevent and regulate all amusements and activities having a tendency to annoy or endanger persons or property on the sidewalks, streets, and other municipal property; and

WHEREAS, the City maintains a municipal park area and facilities within the City and regulations are necessary to ensure the use of the park area is safe and used in a manner to prevent damage or nuisances, and to that end the City has in effect certain regulations codified in the City Code pertaining to the hours of operation of the City Park; and

WHEREAS, the Mayor and City Council find it in the best interest of the City to modify the hours of operation of the City Park to better protect its users and the City, and to enhance all users’ enjoyment of the City park facilities.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ASSUMPTION, CHRISTIAN COUNTY, ILLINOIS, as follows:

Section 1. The Recitals set forth above are hereby incorporated in this Ordinance as if fully set forth herein.

Section 2. Amendment to City Code. Section 7-4-2.A of the City Code is hereby amended as follows (added; ~~deleted~~):

The city park, including the adjacent parking area shall be open to the public daily from ~~dawn eight o'clock (8:00) A.M. in the morning~~ until ~~dusk ten o'clock (10:00) P.M. in the evening~~.

Section 3. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the City of Assumption prior to the effective date of this ordinance.


Section 5. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
